

Station 36 / 00 of said Spur Line, which station is on the property line bearing N. 64 degrees 30 minutes E., between the lands of Mrs. Mary M. Johnson and Mary B. Hartsell; thence S. 64 degrees 15 minutes E., 656.7 feet to Station 42 / 56.7, which station is on the property line, bearing S. 32 degrees 30 minutes W., between the lands of Mary B. Hartsell and W. V. Granger, being substantially the same land as that conveyed by easement from Mary Brown Hartsell to the City of Greenville, South Carolina, dated June 6, 1942, recorded June 18, 1942, Deed Book 245, Page 237, Greenville County, said easement containing 0.90 acres, more or less.

TRACT NO. 42

A 60 foot right-of-way, 30 feet on each side of the center line of the Gantt Station, Greenville Air Base Spur Line, beginning at Station 30 / 88.60 on said Spur Line, which station is on the property line, bearing N. 61 degrees 30 minutes E., between the lands of Misses Minnie and Betty Lenhardt and Mrs. Mary M. Johnson; thence with a 3 degree curve to the left, 494.55 feet to the P.T. of said curve, thence S. 64 degrees 15 Minutes E., 16.84 feet to Station 36 / 00 which station is on the property line bearing 64 degrees 30 minutes W., between the lands of Mrs. Mary M. Johnson and Mary B. Hartsell, being substantially the same land as that conveyed by easement from Margaret M. Johnson to the City of Greenville, South Carolina, dated July 6, 1942, recorded July 8, 1942, Deed Book 245, page 422, said easement containing 0.89 acres, more or less.

TRACT NO. 45

A 70 foot right-of-way, 35 feet on each side of the center line of the Gantt Station, Greenville Air Base Spur Line, beginning at Station 19 / 50.2 of said Spur Line which station is on the property line, bearing N. 54 degrees 58 minutes E., between the lands of Mrs. Rosa Mary Cothran and Minnie O. and Mary E. Lenhardt; thence southeasterly with a 4 degree curve to the right, 349.8 feet to the P. T. of said curve at Station 23 / 00; thence S. 66 degrees 30 minutes E., 150.2 feet to Station 24 / 50.2, which station is on the property line, bearing S. 0 degrees 30 minutes W., between the lands of Minnie O. and Mary E. Lenhardt and S. M. Jones, being substantially the same land as that conveyed by easement from Minnie O. Lenhardt and Mary E. Lenhardt to the City of Greenville, South Carolina, dated July 9, 1942, recorded July 9, 1942, Deed Book 246, page 17, Greenville County, said easement containing 0.80 acres, more or less.

TRACT NO. 46-A

A 70 foot right-of-way, 35 feet on each side of the center line of the Gantt Station, Greenville Air Base Spur Line, beginning at Station 14 / 36 of said Spur Line; thence N. 26 degrees 35 minutes E., 15 feet on the property line dividing the lands of R. C. Simpson and Sue Murray Kern; thence continuing along said property line N. 67 degrees 50 minutes W. to a point on the north line of said 70 foot right-of-way; thence northeasterly along said north right-of-way with a 4 degree curve to the right to a point on the property line dividing the lands of Mrs. Rosa Mary Cothran and Sue Murray Kern; thence along said property line S. 26 degrees 35 minutes W., 40.05 feet to the center line of said Spur Line at Station 15 / 90; thence continuing S. 26 degrees 35 minutes W., 40.05 feet to the south line of said 70
