Leginning at an iron pin on the North side of Anollwood Lane at joint front corner of Lots #166 and #167, thence N.23-50 W. 201.9 feet to an iron pin at joint rear corner of Lots #166 and #167; thence S.65-02 W. 34 feet to an iron pin at the rear center of Lot #168; thence 5.22-09 M. 197.3 feet to an iron pin on the North side of Anollwood Lane at the front center of Lot π 168; thence k.67-51 h. 90 feet along the north side of anoliwood Lane to an iron pin at joint front corner of Lots σ 166 and σ 167, the point of beginning.
