FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is

THIRD: That the principal place of business is 107 E. McBee Ave., GREENVILLE, S.C.

FOURTH: That the general nature of the business which it is proposed to do is to buy, sell, job, distribute, repair and otherwise acquire, dispose of and deal in any and all kinds of auto parts and accessories, supplies and merchandise; to acquire, own, lease and sell real estate and other properties usable in connection with the same; and to transact any and all other business properly incidental to or connected with the purpose of this corporation.
