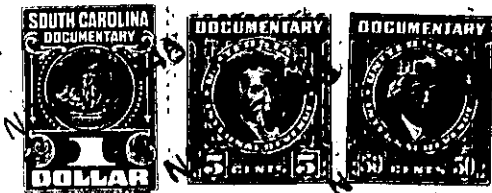

STATE OF SOUTH CAROLINA COUNTY OF GREENVILLE
