4. That no dwelling shall be erected upon said lot that shall cost less than \$10,000.00 (but this restriction shall not apply to servant's quarters erected on the rear of said lot), nor less than 100 feet from right-of-way of Highway # 29.

This deed is executed pursuant to authority contained in the Decree signed by Honorable J. Robert Martin, Jr. dated October 30, 1948 filed in Judgment Rolls #-7212 and E-8970.
