The State of South Carolina } CERTIFICATE OF INCORPORATION
EXECUTIVE DEPARTMENT BY THE SECRETARY OF STATE

WHEREAS, K.L. HEATHERLY, J.T. WELCH and R.D. WOOTEN,
all of Greenville, S.C.;

two or more of the officers or agents appointed to supervise or manage the affairs of
THE GREENVILLE ALUMNI OF THETA CHI FRATERNITY, INC.

which has been duly and regularly organized, did on the 29th day of
December, A. D. 1948, file with the Secretary of State a written declaration setting forth:

That, at a meeting of the aforesaid organization held pursuant to the by-laws or regulations of the said organization, they
were authorized and directed to apply for incorporation.

That, the said organization holds, or desires to hold, property in common for Religious, Educational, Social, Fraternal, Char-
itable or other eleemosynary purpose, or any two or more of said purposes, and is not organized for the purpose of profit or gain
to the members, otherwise than is above stated, nor for the insurance of life, health, accident or property; and that three days'
notice in the Greenville Piedmont, a newspaper published in the
County of Greenville, has been given that the aforesaid Declaration would be filed.

AND WHEREAS, Said Declarants and Petitioners further declared and affirmed:

FIRST: Their names and residences are as above given.

SECOND: The name of the proposed Corporation is: THE GREENVILLE ALUMNI OF THETA CHI
FRATERNITY, INC.

THIRD: The place at which it proposes to have its headquarters or be located is Furman University,
GREENVILLE, S.C.

FOURTH: The purpose of the said proposed Corporation is to maintain a fraternal order
affiliated with the National Chapter of Theta Chi Fraternity, engaging in
the usual social and fraternal activities of such an organization. To hold
property and to further maintain a fraternity house for the use and benefit
of the undergraduate members of Theta Chi enrolled at Furman University and
the alumni members of said fraternity.

FIFTH: The names and residences of all Managers, Trustees, Directors or other officers are as follows:

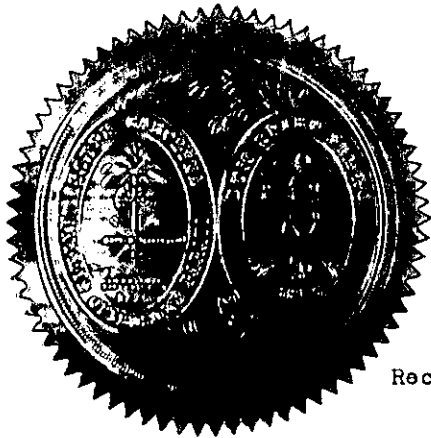
K.L. Heatherly Greenville, S.C.

SIXTH: That they desire to be incorporated: in perpetuity.

NOW, THEREFORE, I, W.P. Blackwell, Secretary of State, by virtue of the authority in
me vested, by Chapter 158, Article III, Code of 1942, and Acts amendatory thereto, do hereby declare the said organization to be
a body politic and corporate, with all the rights, powers, privileges and immunities, and subject to all the limitations and liabilities,
conferred by said Chapter 158, Article III, Sections 8158-8159 and 8168, Code of 1942, and Acts amendatory thereto.
