

Thomson and Emma H. Thomson, their Heirs and Assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the East side of Burns Street in the City of Greenville, County of Greenville, State of South Carolina, being shown as the Southernmost part of Lot #8 on Plat of property of S. O. Skelton prepared by R. E. Dalton, Engineer, in August 1919, (as revised in April of 1924) which plat is recorded in Flat Book E at page 282, R. M. C. Office, Greenville County, S. C., and having according to said plat, the following metes and bounds, to wit:

Beginning at an iron pin on the East side of Burns Street at the joint corner of Lots 8 and 9 and running thence along the East side of Burns Street N. 15-00 E. 44.5 feet more or less to corner of property now or previously owned by J. H. Coker; thence along line of Coker lot S. 86-25 E. 83.4 feet to an iron pin in the Western line of Lot 7; thence along Western line of Lot 7 S. 00-23 W. 45 feet more or less to an iron pin at the joint corner of Lots 7, 8 and 9; thence along joint line of Lots 8 and 9 N. 88-25 W. 100.1 feet to point of beginning.
