

County, State of South Carolina, near the City of Greenville, on the southeast side of Taylor street, (formerly known as Seawright Street), and being known and designated as Lot No. 8, of the property of Lillian M. Rushing, as shown on plat thereof made by Pickell & Pickell, Engrs., on January 15, 1949, and recorded in the R. M. C. offive for Greenville County in Plat Book V, at page 37, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeest side of Taylor street at the corner of Lot No. 9, which point is approximately 180 feet southwest of the intersection of Brockman Street, and running thence along the line of said Lot No. 9, S. 61-24 E. 98.1 feet to an iron pin at the rear corner of said Lot; thence S. 32-19 W 42 feet to an iron pin at the rear corner of Lot No. 7; thence along the line of that lot, N. 61-24 W. 95.5 feet to an iron pin on the southeast side of Taylor street; thence along the line of said Taylor street, N. 28-36 E. 42 feet to the beginning corner.

The above lot is a portion of the property devised to me under the will of Benjamin Lewis Rushing as shown on record in the office of the Judge of Probate for Greenville County in Apartment No. 421, at File No. 1.
