

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. C. HAUBRICK, His Heirs and Assigns, Forever:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, at the intersection of Shadow Lane and Meridian Avenue, being known and designated as Lot No. 49 of a subdivision known as Super Highway Home Sites. The property herein conveyed is described according to a plat of Super Highway Home Sites prepared by Dalton & Neves, Engineers, dated May, 1946, which plat is of record in the R. M. C. Office for Greenville County, S. C., in Plat Book P, at page 53. The property herein conveyed has according to said plat the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the Northern side of Meridian Avenue at the joint corner of Lots No. 48 and 49, and running thence along the common line of said lots, N. 35-0 E. 180 feet to an iron pin, joint corner of Lots No. 49 and 50; thence along the common line of said lots, N. 88-14 W. 169 feet to an iron pin on the Eastern side of Shadow Lane; thence along the Eastern side of Shadow Lane, S. 13-26 W. 119.9 feet to an iron pin; thence along the curve of Shadow Lane as it converges with Meridian Avenue, the chord of which runs S. 34-58 E., 33 feet to an iron pin on the Northern side of Meridian Avenue; thence along the Northern side of Meridian Avenue, S. 83-21 E. 75 feet to an iron pin, the beginning corner.
