LOT NO. 2:

In Greenville Township, at the Southeastern corner of Monteith Circle and Hassie Street, in the City of Greenville, and described as follows:

BEGINNING at a stake at the Southeastern corner of Hassie Street and Monteith Circle, and running thence with the Eastern side of Monteith Circle, S 28-15 E. 150 feet to a stake, corner of Lot No. 3; thence with the line of said lot, N. 58-15 E. 75 feet to a stake at corner of Lot No. 1; thence with the line of said lot, N. 28-15 W. 160 feet to a stake on Hassie Street; thence with the Southern side of Hassie Street, S. 58-15 W. 75 feet to the beginning corner.

LOT NO. 11:

In Gantt Township, on the Southern side of Monteith Circle, just outside of the City of Greenville, and described as follows:
