All that certain piece, parcel or lots of land situate and being on the East side of Carolina Avenue near the City of Greenville in the County of Greenville, State of South Carolina, being shown as lot li of Block J, Section 5 on Plat of East Highlands Estates made by Dalton and Neves, Engineers, February 1941, recorded in the R. M. C. Office of Greenville County, South Carolina in Plat Book K, Page 78, 79 & 80 and having according to said plat the following metes and bounds to wit:

BEGINNING at an iron pin on the East side of Carolina Avenue at joint front corner of lots 11 and 12 of Block J and running thence with the line of lot 12 S. 45-58 E. 168.6 feet to an iron pin; thence N. 87-50 E. 127 feet to an iron pin on West edge of 5 foot strip of land reserved for utilities; thence along the West edge of strip of land reserved for utilities N. 0-24 W. 50. 5 feet to an iron pin in the center of a 3 foot strip reserved for a drain; thence with the center of the strip reserved for a drain N. 63-50 W. 238.3 feet to an iron pin on the East side of Carolina Avenue; thence with the East side of Carolina Avenue along a curved line (the chord being S. 38-04 W. 55 feet) to an iron pin, the beginning corner.

A strip of land 1 1/2 feet in width running along the Morth edge of this lot is subject to an easement for a drain as shown on the recorded plat as above mentioned, and the Grantor reserves to itself, its successors and assigns, the right to retain said drain over that portion of the lot herein conveyed with the right to enter on the premises for the purpose of laying pipes or replacing pipes and to maintain the said drain.
