C., in consideration of the foregoing premises and the sum of One Dollar to us paid by the Fourth Presbyterian Church, Greenville, South Carolina, the receipt whereof is hereby acknowledged, have granted, bargained and sold and released and by these presents do grant, bargain, sell and release unto the said Fourth Presbyterian Church, Greenville, South Carolina, its successors and assigns, all that piece, parcel and lot of land with improvements thereon, situate in the city and county of Greenville, South Carolina, and more particularly described as follows:

Beginning at a point on the East side of Broadus Avenue, which point is 80 feet South of Pettigru Street and is the joint corner of this and the A. G. Furman lot and runs theme along the line of that lot N 64.35 E 167 feet; thence S 41 E 82 feet; thence S 65.52 W 200 feet more or less, to said Broadus Avenue; thence along said Avenue N 15.10 W 72.8 feet to the beginning corner, being the greater part of lot No. 2 as shown by plat recorded in Plat Book A Page 90, wherein this and other lots of the Boyce Lawn Addition are shown.
