That Better Home Builders, Inc. in consideration of the sum of Five Hundred and No/100 (\$500.00) in the State aforesaid, DOLLARS,

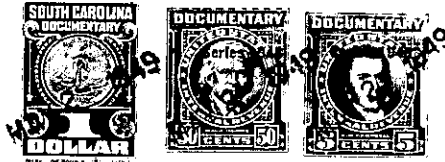
