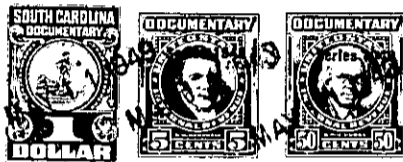
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said D. W. Hawkins, his heirs and assigns forever:

All those two certain lot of land in Chick Springs Township, Greenville County, State of South Carolina, known and designated as lots Nos. 25 and 26 of Block "C" as shown on Plat of Buena Vista Subdivision, which is duly recorded in the R. M. C. Office for Greenville County in Plat Book "W" at Pages 11 and 29, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Sutton Drive, at the joint front corner of lots Nos. 24 and 25 of Block "C" and running thence with line of lot No. 24, N. 80-17 E. 150 feet to an iron pin; thence S. 9-43 E. 70 feet to an iron pin, corner of lot No. 27; thence with line of lot No. 27, S. 80-17 W. 150 feet to iron pin on Sutton Drive; thence with Sutton Drive, N. 9-43 W. 70 feet to the point of beginning.

It is understood that this conveyance is made subject to restrictive covenants applicable to the Subdivision of Buena Vista which are recorded in Deed Book 379 at Page 230.

Grantee is to pay 1949 taxes.
