

Office for Greenville County in Plat Book "S" at Pages 204 and 205, and having according to said plat, when described together, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Watson Road, at the joint front corner of lots Nos. 55 and 54, and running thence with the line of lot No. 54 and lot No. 60, S. 80-12 W. 402 feet to point on Eastern side of a 30 foot street; thence with said street, S. 9-42 E. 95 feet to pin, at corner of lot No. 62; thence with the line of lots Nos. 62 and 56, N. 80-12 E. 402 feet to pin in Watson Road; thence with Watson Road as a line, N. 9-42 W. 95 feet to the point of beginning.
