

County, State of South Carolina, about one mile East from Pelzer on the Holland Ford Road, containing Twenty-two and seventy-eight instantants (22.78) acres, more or less, according to survey and plat made by John C. Smith, Jr. Surveyor, May 1949, which shows the following courses and distances to wit:

BEGINNING at iron pin on West side of dirt road, Cooley corner, thence along said dirt road N. 22-35 W. 5.73 to point in road; thence still along road N. 65-05 W. 1.88 to point in road; thence along road N. 89-05 W. 2.51 to point in center of Holland Ford Road; thence along center of Holland Ford Road N. 20-30 E. 4.03 to point in center of road; thence S. 86-30 E. 3.82 to point; thence S. 71-40 E. 4.68 to iron pin; thence S. 83-15 E. 6.41 to iron pin; thence N. 68-50 E. 9.82 to iron pin on H. P. Beam line; thence S. 36-45 E. 7.20 to stone near branch; thence along Tucker line S. 44-15 W. 9.55 to stone on Cooley line; thence along Cooley line N. 84-45 W. 16.52 to beginning corner on county road. Bounded on the N by lands of G. M. Rice, on the east by lands of H. P. Beam and Tucker, on the south by lands of Cooley, and west by county road and Holland Ford Road.
