E. Hamilton and Alma Boggs Hamilton, their heirs and assions, forever:

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in School District 8-AC and being situate on the Mortheast side of the Worley Road and being more particularly described as follows:

BEGINNING at a stake on the wortheast side of said Road, which stake is 50 feet Southeast of the Southeast corner of said goad and "C" Street, and running thence in a Northeasterly direction 157 fect to a stake in line of property now or formerly of W. J. Gassaway; thence with his line in a Southeasterly direction 135 feet to a stake in line of lot now or formerly of A. E. Black; thence with his line, in a Southwesterly direction 157 feet to a stake on the Worley Road; thence with said Road in a Northwesterly direction 150 feet, more or less, to the beginning.

The above described property is the same conveyed to me and Estelle H. Styles by deed recorded in Deed Book 282, Page 103 and Estelle H. Styles subsequently conveyed her interest to me by deed recorded in Deed Book 304, Page 251. The deeds last referred to described a lot fronting some 200 feet on Worley Road but Bonnie M. Raines had previously consered away 50 feet at corner of said Road and "C" Street by deed recorded in Deed Book 273, Pare 175.
