James S. Street, his heirs and assigns, all that piece, parcel or lot of land in Gantt Township, County of Greenville, State of South Carolina, lying and being situate on the Southern side of Potomac Avenue, in the limits of the City of Greenville, South Carolina, being known and designated as Lot # 236, Pleasant Valley, according to plat of said subdivision prepared by Dalton & Neves, Engineers, recorded in the R.M.C. Office for Greenville County in Plat Book "P", at Page 93, and having, according to said Plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Potomac Avenue, joint front corner of Lots # 235 and # 236; thence S. 0-08 E. 160 feet to an iron pin at joint rear corner of Lots # 235 and # 236; thence N. 89-52 E. 60 feet to an iron pin at joint rear corner of Lots # 236 and # 237; thence N. 0-08 W. 160 feet to an iron pin on the Southern side of Potomac Avenue, joint front corner of Lots # 236 and # 237; thence S. 89-52 W. 60 feet along said Potomac Avenue to an iron pin at joint front corner of Lots # 235 and # 236, the point of beginning.
