

KNOW ALL MEN BY THESE PRESENTS, That Lloyd Almoe, Sam

in the State aforesaid, in consideration of the sum of Ten (.10.00) and other valuable considerations Dollars to me in hand paid at and before the sealing of these presents by Conyers & Gower, Inc., (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Conyers & Gower, Inc., its successors and assigns, forever:

All those certain pieces, parcels or lots of land, situate, lying and being on the Northwest side of Johnson Street in that area recently annexed to the City of Greenville in Greenville County, S. C., being shown as Lots 1 o. 123 and 1^{1/4} on plat of East Lynn Addition, made by Dalton & Neves, Surveyors, May 1933, recorded in the U. S. Office for Greenville County, S. C. in Plat book , page 220 and having according to said plat the following metes and bounds to-wit:

GINING at an iron pin on the Northwest side of Johnson Street at joint front corner of Lots 122 and 123 and running thence with the line of Lot 122, N. 61-10 W. 200 feet to an iron pin: thence N. 04-51 E. 100 feet to an iron pin: thence with line of Lots 125, 126 and 127 S. 61-10 E. 200 feet to an iron pin on Northwest side of Johnson Street: thence with Northwest side of Johnson Street N. 4-10 E. 10 feet to point of beginning.

ALSO, all that piece, parcel or lot of land, situate, lying and being on the Northeast side of Macnair Drive in that area recently annexed to the City of Greenville in Greenville County, S. C., being shown as Lot No. 1^{1/4} on plat of East Lynn Addition, made by Dalton & Neves, Surveyor, May 1933, recorded in the U. S. Office for Greenville County, S. C. in Plat book , page 220 and having according to said plat the following metes and bounds to-wit:

GINING at an iron pin on the Northeast side of Macnair Drive joint front corner of Lots 143 and 144 and running thence with line of Lots 142 and 143 N. 28-50 E. 252.6 feet to an iron pin on Northwest side of Ridgeway Drive: thence with the Northwest side of Ridgeway Drive E. 37-32 E. 70 feet to an iron pin: thence with line of Lot 145 S. 22-31 E. 226 feet to an iron pin on Northeast side of Macnair Drive: thence with Northeast side of Macnair Drive N. 4-10 E. 10 feet to beginning corner.
