All that certain piece, parcel or lot of land situate, lying and being on the West side of Penn Street (formerly known as Smith Street) in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as a portion of Lot 110 on plat of D. T. Smith Estate, made by Dalton & Neves, Engineers, May 1935, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book H, page 279, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Penn Street in front line of Lot 110, said pin being 317.2 feet in a Northerly direction from the Northwest corner of the intersection of East Tallulah Drive and Penn Street, and running thence S. 64-40 W. 150 feet to iron pin; thence N. 25-20 W. 3.4 feet to iron pin; thence N. 64-40 E. 150 feet to iron pin on the West side of Penn Street; thence along the West side of Penn Street S. 25-20 E. 3.4 feet to the beginning corner.
