TO HAVE AND TO HOLD the above granted property to the said ERNEST ROBERT DODSON, JR. -----

heirs and assigns, forever; subject, however, to the restrictions and limitations above referred to.

And GRACELAND CEMETERY DEVELOPMENT CO., INC., for itself, and successors and assigns, covenants
with the said ERNEST ROBERT DODSON -----
that the lot shall receive general care as specified in Rule No. 5 on the reverse side hereof to which reference is made.


And GRACELAND CEMETERY DEVELOPMENT CO., INC., does hereby bind itself and its successors to



