TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Arthur W. Hill County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembly of South Carolina and the statute laws of said State, against Lymon Burgess

defaulting taxpayer(s) of said County, strictly charging and commanding said Delinquent Tax Collector of said County to levy by distress and sale of the lands of the said Lymon Burgess tax defaulter(s), the sum of Seventeen & 06/100 including the penalties on said tax execution(s) for the year(s) 1942-1943-1944-1945-1946 together with charges and costs thereof; and

WHEREAS, by virtue and authority of said warrants M.L. Ashmore the delinquent tax collector of the State and County aforesaid, did on the 14th day of April 1948 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of May during the usual hours of sale, after due advertisement, sell the same to J.T. Stallings and his heirs and assigns, the purchaser(s), hereinafter known as "grantee(s)", and the highest bidder at such sale, for the sum of Thirty One & no/100 and gave a receipt for said purchase money to him; and

WHEREAS, more than twelve months have elapsed since the date of said sale, and the defaulting taxpayer(s), or any other party interested, have failed to redeem said land so sold for taxes;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That I, M.L. Ashmore, Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of Thirty One & no/100 Dollars to me paid by the said grantee(s), J.T. Stallings

have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee(s), J.T. Stallings

his heirs and assigns: All that certain, piece parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville in the vicinity known as "Nicholtown", and being known and designated as lot # 15, block "A" of Jefferson Heights as shown by a plat recorded in the R.M.C. Office in plat book "C" page 34 and 35, said lot fronting 25.5 feet on First Ave. And running back on one side 87.5 feet, and being 25.5 Feet in the rear and 87.5 Feet on the other side, bounded by lot nos. 14, 16, and 40 of the above mentioned plat.
