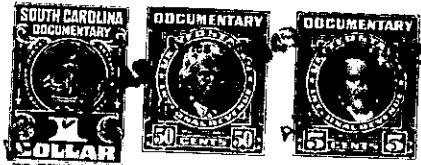
Know All Men by These Presents:

That We, Noland Meyers, Lillie M. Meyers and Hilda O. Meyers in the State aforesaid, in consideration of the sum of Five Hundred (\$500.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Frances W. McKinney, her heirs and assigns all that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina as shown by plat of Parkvale, a subdivision plat recorded in Plat Book K Page 54 being known as Lots No. 11 and 12, situated in Section C of said subdivision and more particularly described as follows:

BEGINNING at an iron pin on Meyers Court corner of Lot No. 13 and running thence with line of Lot No. 13 N. 83-0 W. 150 feet to an iron pin corner of Lots No. 4 and 5; thence along the line of Lot No. 5 N. 7-30 E. 70 feet to an iron pin corner of Lots No. 5 and 6; thence along the line of Lot No. 6 N. 7-30 E. 70 feet to an iron pin corner of Lots No. 7 and 10; thence along the line of Lot No. 10 S. 82-50 E. 150 feet to an iron pin on Meyers Court; thence along said Court S. 7-30 W. 140 feet to the point of beginning.

This conveyance is made subject to the restrictions and conditions contained in the agreement recorded in the R.M.C. Office in Deed Book 227 Page 173 to which reference is here made and the same made a part hereof as fully as if specifically set forth in this deed.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
