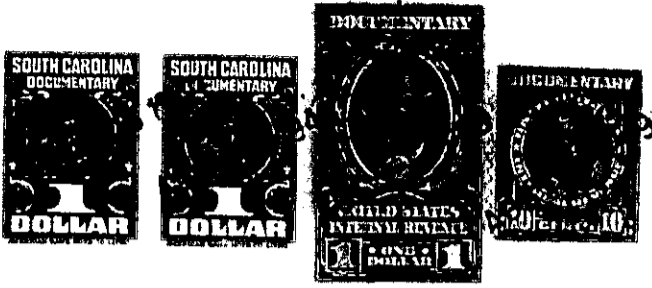

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these
presents do grant, bargain, sell and release unto the said David D. Davenport, his Heirs
and assigns forever

all that piece, parcel or lot of land in Chick Springs Township, Greenville
County, State of South Carolina, about one mile north from Chick Springs,
lying on the east side of the St. Mark Road, being shown and
designated as lots 1, 2, 43, 44, 45 and 46 on Plat of Property
W. B. Williams, made by H. L. Dunahoo, January 21st 1947,
and being a part of the same property conveyed to me by
deed from W. B. Williams, and having the following courses
and distances, to wit:-

Beginning on an iron pin on the east side of St. Mark
Road and on the north side of an unnamed road, the southwest
corner of lot No. 1, and runs thence with the northern side
of the unnamed road N. 67-35 E. 200 feet to an iron pin, joint
corner of lots 1 and 46; thence continuing with the northern
side of the unnamed road N. 59-20 E. 150 feet to an iron pin
joint corner of lots 43 and 44; thence continuing with the
northern side of the said road N. 89-30 E. 50 feet to an iron
pin, joint corner of lots 42 and 43; thence with the dividing
line of lots 42 and 43 in a northern direction 190 feet to an
iron pin, joint corner of lots 12, 13, 43 and 42; thence S. 63-
30 W. 272 feet to an iron pin, joint corner of lots 5, 4, 8 and
46; thence S. 20-10 E. 50 feet to an iron pin on the line of
lot No. 46 and joint corner of lots 2 and 3; thence with the
dividing line of lots 2 and 3 S. 67-35 W. 204 feet to an iron
pin on the east side of the St. Mark Road; thence with the east
side of the said road S. 23-00 E. 100 feet to the beginning co
corner.
