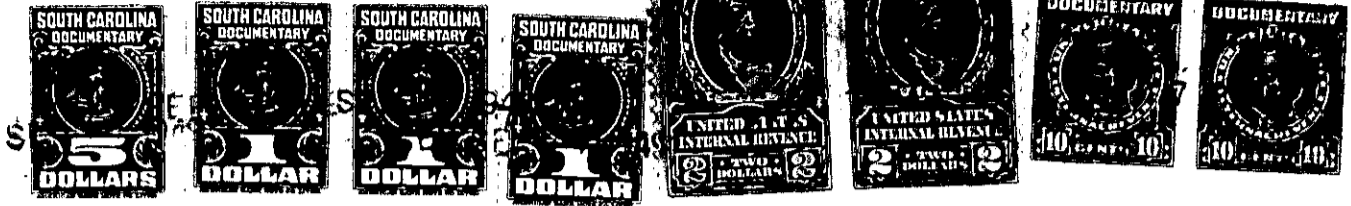

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these
presents do grant, bargain, sell and release unto the said J. P. Henderson and Alice

Henderson, their Heirs and Assigns forever

all that piece, parcel or lot of land in Butler Township, Greenville

County, State of South Carolina, located on the west side of the Five Forks
and Batesville Road, being bounded on the north by lands of
Roberts and Mrs. Adams, on the east by the said road, on the
south by lands of _____, and on the west
by a lot of five acres conveyed by me to J. E. Fowler and an
one acre lot conveyed by me to Mrs. Maude Vaughn, and being
the remainder of the land that was conveyed to me by deed
recorded in the office of the R. M. C. for Greenville County
in Deed Book 357 at page 498, and having the following courses
and distances, to wit:-

Beginning at a stone on the west side of the Batesville
Road at the corner of property now or formerly belonging to
McGee, and running thence along the center of the said road
N. 4-30 W. 138.5 feet to a point in the center of the road;
thence still along the center of the said road N. 10-40 E.
616 feet to a point in the center of the said road opposite a
Post Oak at the corner of property now or formerly belonging
to Mrs. Adams; thence along the line of the Adams property
N. 71-30 W. 321 feet to an iron pin at the corner of E. W.
Roberts property; thence along the line of the Roberts prop-
erty N. 75-15 W. 503 feet to a point in the center of the
Roberts Road in line of property of J. E. Fowler; thence
along the center of the said road S. 24-30 W. 700 feet to a
point in the center of the said road at the corner of property
formerly of McGee, now Smith; thence along the line of the
Smith property S. 72-15 E. 1033 feet to the beginning corner, a
and containing Fifteen and Sixteen One-hundredths (15.16) acres,
more or less.

LESS HOWEVER Five Acres (5) conveyed by me to J. E. Fowler
by Deed recorded in Vol. 376 at page 93, and having the follow-
ing courses and distances, to wit:-

Beginning on a point in the center of the said Roberts
Road, joint corner of the one (1) acre lot conveyed by me to
Mrs. Maude Vaughn, and runs thence with the Vaughn line, S. 72-15 E.
375.5 feet to an iron pin; thence N. 24-30 E. 604 feet to an
iron pin on the Roberts line; thence with the Roberts line
N. 75-15 W. 378 feet to a point in the said Roberts Road (iron
pin on east side of road on line); thence with the center of
the road S. 24-30 W. 583 feet to the beginning corner,
