Fleming, herein called grantees, all that piece, parcel or lot of land in Greenville Township, Greenville Co., State of S.C. on the south side of a 25' alley extending north from Townes St. Extension, more particularly described as follows:

BEGINNING at an I.P. on the south side of said alley, corner of property of Ruth B. Roland, which I.P. measures 166' east along said alley from Townes St., and running thence along said alley S. 80-08 E. 50' to an I.P.; thence S. 9-52 W. 110.3' to I.P.; thence N. 71-50 W. 50.5' to I.P. at rear corner of Ruth B.
