


All that certain piece, parcel or lot of land with buildings and improvements thereon situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, on the Southern side of Blue Ridge Drive, being described according to a plat prepared by the Piedmont Engineering Service, Treenville, S.
