

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Joseph P. Yesbeck and Ruth G. Yesbeck, their Heirs and Assigns forever,

All that piece, parcel or lot of land situate, lying and being on the East side of North Main Street, near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot No. 54 on Plat of North Park, recorded in the R. M. C. Office for Greenville County in Plat Book K at Pages 48 and 49, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of North Main Street at joint front corner of Lots Nos. 54 and 55, said pin also being 60 feet North from the Northeast corner of the intersection of North Main Street and Gallivan Avenue, and running thence with the line of Lot No. 55, S. 68-34 E. 162 feet to an iron pin; thence N. 19-06 E. 60 feet to an iron pin; thence with the line of Lot No. 53, N. 68-34 W. 162.3 feet to an iron pin on the East side of North Main Street; thence with the East side of North Main Street, S. 19-46 W. 60 feet to the beginning corner.

As a part of the consideration the Grantee assumes and agrees to pay the balance of \$7,067.92 due on a mortgage executed to Franklin National Life Insurance Company dated March 9, 1948, recorded in Mortgage Book 382 at Page 320; and also to pay the balance due on a mortgage held by F. B. Pinson, said mortgage being in the original sum of \$1500.00 and recorded in Book of Mortgages 397 at Page 274, the balance due as of October 1st, 1949 being 1007.36.

Said premises being the same conveyed to the Grantor by Beatrice S. Miller by deed recorded in Book of Deeds 356 at Page 85.
