to it in hand duly paid at and before the sealing and delivery of these presents by the grantee John W. Cleveland, hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto The Bank of Greenville and Alice Burnett Cleveland, administratrix of the Estate of W. C. Cleveland, deceased, their heirs, executors and assigns, forever:

' All that piece, parcel or lot of land situate, lying and being in the City of Greenville, Township of Greenville, County of Greenville, State of South Carolina, near the intersection of Washington Place and East Washington Street and being more particularly described according to a plat thereof prepared by J. W. Cleveland, Civil Engineer on August 13th, 1948, which plat is recorded in the Office for Greenville County, S. C. in Plat Book W, page 79, as follows, to-wit:

BEGINNING at an iron pin on the North side of the said Washington Street at the present Northeast corner of Pleasant Street, thence running thence with the South side of East Wallin Street to the South 50 East 10.5 feet to an iron pin; thence a curved line to the South which has the following 4 courses in degrees South 87-45 West 30 feet to an iron pin; thence South 26-43 East 25 feet to an iron pin; thence South 3-22 West 25 feet to an iron pin; thence South 27-30 West 30.5 feet to an iron pin on the North side of Washington Place; thence with the North side of Washington Place, North and West 50 feet to an iron pin; thence a curved line to the South 87-45 West 33. West 100 feet to the beginning corner.

The above is a part of the property conveyed to the above named to the City of Greenville, S. C. by deed dated June 11, 1948, recorded in the R. L. C. Office for Greenville County, S. C., Volume 3, Page 240, which conveyance was for paid value, and the remaining portion of the property conveyed to the above named to the said W. C. Cleveland lying East of the above described property, thereof hereby reconveyed to his Estate is expressly retained by the City of Greenville for street purposes and this provision for the use of the portion retained by the City is a part of the original conveyance for the reconveyance of the above described portion of said property.
