All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, in a subdivision known as Medical Court, being known and designated as Lot No. 2 of said subdivision and being described according to a plat prepared by the Piedmont Engineering Service, Greenville, S. C., dated September, 1949, entitled "Plat of Medical Court, Greenville, S. C.", which plat is of record in the R. M. C. Office for Greenville County, S. C., in Plat Book W, at page 77. BEGINNING at a point in the center of a 20-foot street at the joint front corner of Lots Nos. 1 and 2, which point is 102 feet from the intersection of said 20-foot street and Pendleton Street, and running thence along the common line of Lots Nos. 1 and 2 S. 71-27E 80 feet to an iron pin; thence S. 18-24 W. 50 feet to an iron pin, the joint rear corner of Lots Nos. 2 and 3; thence along the common line of Lots Nos. 2 and 3 N. 71-27 W. 80 feet to a point in the center of the aforementioned 20-foot street; thence along the center of said 20-foot street N. 18-24 E. 50 feet to the beginning corner.

This property is conveyed subject to, and with the benefit of, easements and restrictions established for the mutual benefit of all the property in Medical Court subdivision, as shown on plat of said subdivision, recorded in the R.
