Know All Men by These Presents:



That I, Harold B. McKinney, in the State aforesaid, in consideration of the sum of (\$7900.00) Seven Thousand Nine Hundred and no/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMES LEWIS WHITING, his heirs and assigns, all that certain piece, parcel or lot of land situate, lying and being on the South side of Fairview Avenue in the City of Greenville, Greenville County, South Carolina, and being shown as Lot #14, Block K, Section 5, on plat of East Highlands Estates recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book K, pages 78, 79 and 80, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Fairview Avenue at joint front corner of Lots #12 and #14 of Block K, and running thence along the line of Lot #12 S. 7-13 E. 175 feet to an iron pin on the North edge of a five-foot strip of land reserved for utilities; thence along the North edge of said strip S. 82-47 W. 70 feet to an iron pin; thence along the line of Lot #16 N. 7-13 W. 175 feet to an iron pin on the South side of Fairview Avenue; thence with the South side of Fairview Avenue N. 82-47 E. 70 feet to the beginning corner.



Grantee is to pay the 1949 taxes.

This is the same property conveyed to me by deed from Conyers & Gower, Inc. dated July 14, 1949, and recorded in the R.M.C. Office for Greenville County in Deeds Volume 386, at page 293.

This property is subject to the following restrictions: (1) The lot herein conveyed shall be used for residential purposes only. (2) The lot herein conveyed shall never be sold, rented or otherwise disposed of to Negroes or persons of African descent. (3) No residence shall be erected on said lot costing less than \$3,000.00. (4) The building line as shown on the recorded plat and also other restrictions shown on said plat are to be strictly adhered to.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

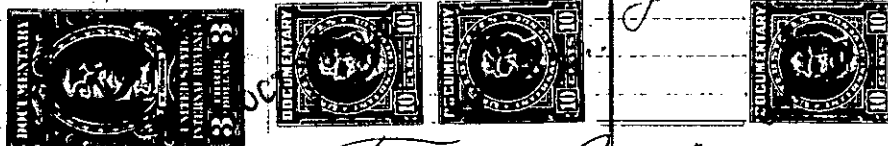
