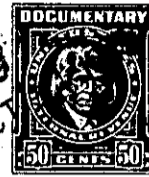
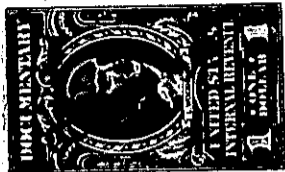

 does grant, bargain, sell and release unto R. E. Ingold, his heirs and assigns, forever:

All that certain piece, parcel or tract of land situate, lying
 and being on the West side of Cavalier Drive in Butler Township, Green-
 ville County, S. C. containing 8.95 acres according to survey made by
 R. E. Dalton, Engineer, February 1944, recorded in the R.M.C. Office for
 Greenville County, S. C. in Plat Book W, page 93 and having
 according to said plat the following metes and bounds, to-wit:

BEGINNING at a point in the center of Cavalier Drive said point
 being at a bend in said Drive and at corner of lands conveyed by Grantor
