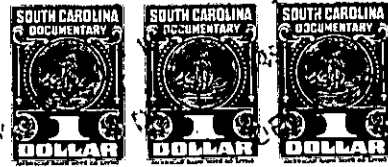

Know All Men by These Presents:

That I, Mrs. Geanie L. Caldwell in consideration of the sum of Fourteen Hundred Forty (\$1440.00) CLUE FARNSWORTH in the State aforesaid, R.M.C. DOLLARS, F.L. Chandler

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said F.L. Chandler and his heirs and assigns: All of those parcel or lots of land situate and being in Chick Springs Township of Greenville County, South Carolina, lying North from the City of Greer and the U.S. Dual Lane Highway No. 29, being all of lots Nos. 27, 28, 29, 58 and 12 on a plat of property made for Mrs. Geanie Caldwell by H.L. Dunahoo, Surveyor, dated October 24-25, 1949, recorded in the R.M.C. Office for Greenville County in Plat Book X, at page 1. Lot No. 12 lies on the West side of Ashmore Street and fronts thereon 70 feet, having a rear width of 70 feet and an uniform depth of 194 feet. Lots Nos. 27, 28 and 29 lie on the North side of Highland Drive and have a combined frontage thereon of 210 feet, having a combined rear width of 210 feet and such depth as appears by reference to said plat. Lot No. 58 lies on the East side of Caldwell Street and fronts thereon 70 feet. Reference to said plat and record thereof is expressly made for a detailed and complete description of the aforesaid lots.

This property is to be used only for residential purposes with desirable appurtenances thereto, for White people only, and specifically prohibited are trailer camps, tourist courts, clubs, dance halls and so-called "honky-tonks" or "juke-joints", and the sales of beer, wine and alcoholic liquors. No dwelling shall be erected for a cost of less than \$3,500.00, and the same must be placed at least 20 feet from the street on which it faces. These restrictions are for the benefit of the grantor and all owners of the property in this subdivision, and any violation thereof shall entitle any owner of the same to injunctive relief. However, the rights of lien creditors shall not be impaired by any violations of these restrictions.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

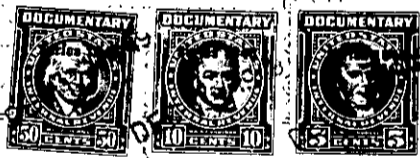
