Know All Men by These Presents:

That I, David G. Traxler, in consideration of the sum of Seven Hundred and No/100 (\$700.00) and assumption of mortgage hereinbelow referred to in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JOS. B. BALENTINE, his heirs and assigns, all that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, lying and being situate on the Northern side of Prancer Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot #269, Pleasant Valley, according to plat of said sub-division prepared by Dalton & Neves in April, 1943, including additions to said Flat through November, 1948, as recorded in the R.M.C. Office for Greenville County in Plat Book "P", at Page 92, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Prancer Avenue, at joint front corner of Lots # 268 and #269, said pin being 480 feet Southwest of iron pin at common corner of Lots # 260 and # 261 on the Northern side of Prancer Avenue at junction of Prancer Avenue with Phoenix Avenue and Long Hill Street; thence N. 0-08 W. 160 feet to an iron pin at joint rear corner of Lots # 268 and # 269; thence S. 89-52 W. 60 feet to an iron pin at joint rear corner of Lots # 269 and #270; thence S. 0-08 E. 160 feet to an iron pin at joint front corner of Lots # 269 and # 270 on the Northern side of Prancer Avenue; thence along said Avenue, N. 89-52 E. 60 feet to iron pin at joint front corner of Lots # 268 and # 269, the point of beginning.

The above described property is subject to restrictions recorded in the R.M.C. Office for Greenville County in Deeds Volume 301, at page 60, as amended in Volume 367, at page 106.

As a part of the consideration hereof, the grantee assumes and agrees to pay, according to its terms, that certain note and mortgage dated June 9, 1949, given by David G. Traxler in favor of The First National Bank, Greenville, South Carolina, securing the sum of \$3,000.00, said mortgage being recorded in the R.M.C. Office for Greenville County in Mortgage Volume 429, at Page 271.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

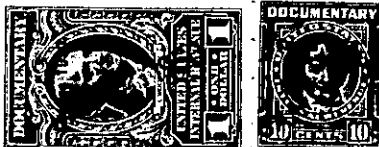
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
