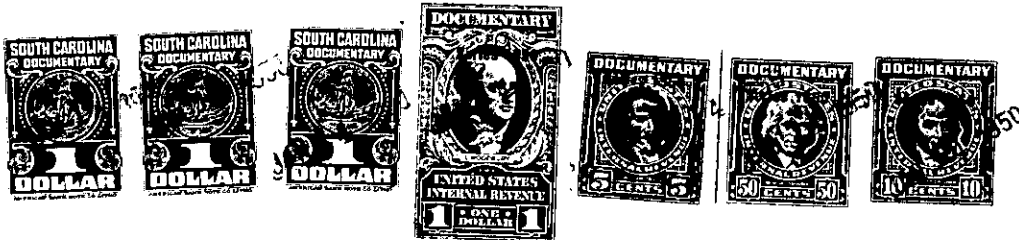

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Joe R. Allen, his heirs and assigns;

All that certain piece, parcel or lot/land with the buildings and improvements thereon, lying and being on the Southerly side of Alabama Avenue, near the City of Greenville, S. C., being shown as lot #104 on the Plat of the Talmer Cordell Subdivision, recorded in the RMC Office fo Greenville County, S. C., in plat Book "V", page 198, and having according to said plat the following notes and bounds to-wit:

BEGINNING at an iron pin on the Southerly side of Alabama Avenue at a point 246 feet in a westerly direction from the Southwest corner of the intersection of Alabama Avenue and Texas Avenue at the joint front corner of lots #103 and 104 and thence along the line of said lots S 29-17 W 200 feet to an iron pin; thence N 60-43 W 61 feet to an iron pin; joint rear corner of lots 104 and 105; thence along the line of said lots N 29-17 E 200 feet to an iron pin on the Southerly side of Alabama Ave.; thence along the Southerly side of Alabama Avenue S 60-43 E 61 feet to the point of beginning. This property is conveyed subject to the restrictions recorded in Deeds 380, page 192.

This property is conveyed subject to a mortgage given by Talmer Cordell to Carl W. Garrison d/b/a Blue Ridge Lumber Co. dated Oct. 19, 1949 in the amount of \$4500.00 and recorded in the RMC Office for Greenville County, S. C. in Mtg. 439, page 388. This mortgage was assigned by Garrison to the Peoples National Bank on Dec. 2, 1949.
