M. and ROSA LEE BISHOP, their heirs and assigns,

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the South side of Parkins Mill Road, being known and designated as Lot #1, according to a plat of the property of John B. Scoggins prepared by W. J. Riddle, Surveyor, August, 1949, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Parkins Mill Road, said pin being 430 feet more or less to the intersection of Parkins Mill Road and Augusta Road, and running thence S. 18-30 W. 168.2 feet to an iron pin; thence South 45 feet to an iron pin; thence S. 56-55 E. 136 feet to an iron pin; thence N. 18-30 E. 200 feet to a point on Parkins Mill Road; thence along Parkins Mill Road N. 65-55 W. 29.9 feet to an iron pin; thence continuing along Parkins Mill Road N. 51-20 W. 122 feet to an iron pin, the point of beginning.
