

All those certain pieces, parcels or lots of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Western side of Brookwood Drive in a subdivision known as Stone Estates, being known and designated as Lots 35, 36, 39 and 40, Block D, of said subdivision, and being described according to a plat prepared by C. BEGINNING at a point on the Western side of Brookwood Drive at the joint front corner of Lots 34 and 35, and running thence along the common line of said lots N. 78-38 W. 160 feet, more or less, to a point, the joint corner of Lots 4, 5, 34 and 35; thence along the common line of Lots 5, 6, 35 and 36, N. 11-22 E. 50 feet, more or less, to a point, the joint rear corner of Lots 6, 7, 36 and 37; thence along the common line of Lots 36 and 37 S. 78-38 E. 160 feet, more or less, to a point on the Western side of Brookwood Drive; thence along the Western side of Brookwood Drive S. 11-22 W. 50 feet, more or less, to the beginning corner.

Lots 39 and 40, Block D, are described as follows:

BEGINNING at a point on the Western side of Brookwood Drive at the joint corner of Lots 38 and 39, and running thence along the common line of said lots N. 78-38 W. 160 feet, more or less, to a point, the joint rear corner of Lots 8, 9, 38 and 39; thence along the common line of Lots 9, 10, 39 and 40, N. 11-22 E. 50 feet, more or less, to a point, the joint rear corner of Lots 10, 11, 40 and 41; thence along the common line of Lots 40 and 41 S. 78-38 E. 160 feet, more or less, to a point on the Western side of Brookwood Drive, the joint front corner of Lots 40 and 41; thence along the Western side of Brookwood Drive S. 11-22 W. 50 feet, more or less, to the beginning corner.
