RELEASE FROM JUDGMENT

Jamison, the owners and holders of a certain judgment in the sum of Five Hundred, Seventy-Eight and 07/100 - (\$578.07) Dollars against Eva B. Poole as shown by Judgment Roll E-12,331 in the office of the Clerk of Court for Greenville County for and in consideration of the sum of Two Hundred, Fifty and No/100 - (\$250.00) Dollars, does hereby release, relinquish and forever discharge from the lien of said judgment the following described real estate:

"All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the West side of East North Street in Ward Two of the City of Greenville, and being known and designated as Lot No. 2 on plat of the property of Annie Griffin, et al., made by Dalton and Neves, Engrs., in January, 1929 and recorded in the R. M. C. office for Greenville County in Plat Book H, at pages 178 and 179, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the West side of East North street at the corner of Lot No. 1, which point is 70.7 feet North from the Northwest corner of the intersection of East North Street and Richland avenue, and running thence along the line of Lot No. 1, N. 77-03 W. 180.8 feet to an iron pin in the line of Lot No. 25; thence along the line of that lot, N. 20-41 E. 70.3 feet to an iron pin at the rear corner of Lot No. 3; thence along the line of that lot, S. 77-03 E. 163.4 feet to an iron pin at the corner of said lot on the West side of East North street; thence along the line of said East North street, S. 6-24 W. 70 feet to the beginning corner; being the same lot of land conveyed to Eva B. Poole by G. L. Chiles and Lilla L. Chiles by deed dated February 20, 1948, recorded in the R. M. C. office for Greenville County in Vol. 339, page 18."
