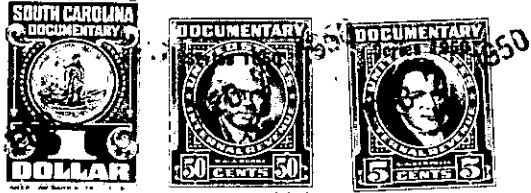

KNOW ALL MEN BY THESE PRESENTS, That I, James H. Miller, of the County of Greenville, State of South Carolina, in consideration of the sum of Two Hundred and Sixty Dollars to me in hand paid at and before the sealing of these presents by Curtis Suter and Nellie C. Suter (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Curtis Suter and Nellie C. Suter, their heirs and assigns forever

all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, about three miles west from the City of Greenville, lying on west side of the Suter Road, being bounded on the west and north by lands of Mrs. Copeland, on the east by the Suter Road and on the south by other lands of myself, and being a part of the land that was conveyed to me by James A. Suter, deceased, in the office of the R. L. J. for Greenville County, in Book 432, Page 77, and having the following courses and distances, to-wit:

Beginning on a nail and stopper in the center of the Suter Road, and run thence with the line of Mrs. Copeland S. 89-30 W. 100 feet to an iron pin on the west bank of the Suter Road, then continue with the same course—S. 89-30 W.—for a total distance of 100 feet to an iron pin, Mrs. Copeland's corner; thence with the line of Mrs. Copeland S. 2-33 W. 100 feet to an iron pin on the west bank of the Suter Road; thence with the line of Mrs. Copeland S. 89-30 W. 100 feet to a nail and stopper in the center of the Suter Road, and being 100 feet wide; thence with the line of Mrs. Copeland S. 89-30 W. 100 feet to a nail and stopper in the center of the Suter Road, and being 100 feet wide; thence with the line of Mrs. Copeland S. 89-30 W. 100 feet to a nail and stopper in the center of the Suter Road, and being 100 feet wide.
