All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, being known and designated as Lot No. 8, Block H, according to plat of property of Fair Heights of record in the R. M. C. Office for Greenville County in Plat Book F, Page 257, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Brookdale Avenue at the joint front corner of Lots 7 and 8 and running thence along the line of Lot No. 7, N. 58-40 W. 150 feet to an iron pin at the rear corner of Lot No. 17; thence along the rear line of Lot No. 17, S. 31-20 W. 50 feet to an iron pin at the rear corner of Lot No. 9; thence along the line of Lot No. 9, S. 58-40 E. 150 feet to an iron pin on Brookdale Avenue; thence along Brookdale Avenue, N. 31-20 E. 50 feet to an iron pin at the point of beginning.

- The above described property is subject to the following restrictions:
1. Said premises shall not be sold, rented or otherwise disposed of to person or persons of African descent.
 2. No residence shall be erected on said premises costing less than \$1500.
 3. No building shall be erected on said lot nearer than 25 feet to the front property line.
 4. Said premises shall be used exclusively for residential purposes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
