

All that certain piece, parcel or lot of land lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Eastern side of an unnamed street and being known and designated as Lot #15 of Nichol Town No. 4, as shown on plat of W. J. Riddle, Surveyor, dated November 3, 1943, and recorded in the R. M. C. Office for Greenville County in Plat Book "N", Page 139, and having according to said plat the following metes and bounds, to-
