BEGINNING at an iron pin on the Northeast side of East Welborn Street at joint front corner of Lots No. 42 and No. 43, said pin being 71.6 feet North-west of point of intersection of Railroad Avenue with East Welborn Street, thence N. 42-40 E. 129 feet along the line of Lot No. 42 to an iron pin at joint rear corner of Lots Nos. 42 and 43; thence N. 47-20 W. 71.5 feet to an iron pin at joint rear joint rear corner of Lots Nos. 43 and 44; thence S. 42-40 W. 129 feet along the line of Lot No. 44 to an iron pin on the Northeast side of East Welborn Street at joint front corner of Lots No. 43 adn 44; thence S. 47-20 E. 71.5 feet along said Street to an iron pin at joint front corner of Lots Nos. 42 and 43, the point of beginning.
