to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Paul E. Lindsey and Audrey W. Lindsey, their heirs and assigns:

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 7 and the Northern one-half of Lot No. 6 as shown on a Plat of the Property of Revalee Cartee prepared by Dalton & Neves, Engineers, in January 1950, and being more particularly described according to said Plat as follows:

BEGINNING at an iron pin at the Southwest intersection of Nash Street and Cartee Avenue, and running thence with said Avenue, S. 77-57 W. 244.3 feet to an iron pin at joint rear corner of Lots Nos. 6 and 7; thence with the rear line of Lot No. 6, S. 23-11 W. 50 feet to a point in the center of rear line of Lot No. 6; thence through the center of Lot No. 6, S. 67-15 E. 200 feet to a point on the Western side of Nash Street in the center of the front line of Lot No. 6; thence with said Street, N. 23-11 E. 189.6 feet to the point of beginning.
