to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WACO F. CHILDERS, JR., his heirs and assigns, all that piece, parcel or lot of land, in Greenville Township, County of Greenville, State of South Carolina, lying and being situate on the Southern side of De Oyley Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot # 25, Augusta Road Ranches, according to plat of said Subdivision prepared by Dalton & Neves in April 1941, as revised through April 1942, as recorded in the RMC Office for Greenville County in Plat Book "M", at Page 47, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of De Oyley Avenue at joint front corner of Lots # 25 and # 24, said pin being 313.4 feet in a Westerly direction from an iron pin in the Southwest intersection of De Oyley Avenue and Old Augusta Road, and running thence S. 0-13 E. 200 feet to an iron pin at joint rear corner of Lots # 25 and # 24; thence S. 89-47 N. 60 feet to an iron pin at joint rear corner of Lots # 25 and # 26; thence N. 0-13 W. 200 feet to an iron pin at joint front corner of Lots # 25 and # 26; on the Southern side of De Oyley Avenue; thence along said Avenue N. 89-47 E. 60 feet to an iron pin at joint front corner of Lots # 25 and # 24, the point of beginning.

The herein named grantee is to pay the 1950 taxes on the above-described property.
