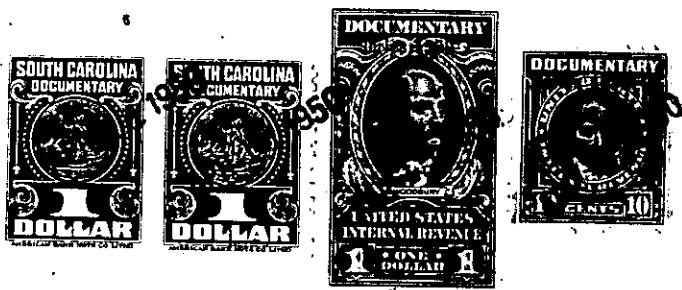

KNOW ALL MEN BY THESE PRESENTS, That I, Hext N. Perry, Trustee, of the  
County of Greenville, -----  
in the State aforesaid, in consideration of the sum of ten dollars (\$10.00.) and other valu-  
able considerations, ----- ~~to~~  
to ----- in hand paid at and before the sealing of these presents  
by Paul L. Fair  
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these  
presents do grant, bargain, sell and release unto the said Paul L. Fair, his heirs and assigns  
forever:

all that piece, parcel or lot of land in -----Greenville--- Township, Greenville-----  
County, State of South Carolina, on Darlington Avenue between Berkley Avenue and Dyke-  
son Avenue, in the Sans Souci section of Greenville County, about three miles  
north of the City of Greenville, said lot having the following lines, courses  
and distances, to wit:-

Beginning at an iron pin on the western edge of a five (5) foot sidewalk  
running along Darlington Avenue, said pin being the joint front corner of lots  
numbered sixteen (16) and seventeen (17), and running thence along the southern  
edge of said sidewalk, S. 43-0 W., sixty (60) feet, to an iron pin, joint front  
corner of lots fifteen (15) and sixteen (16); thence along the northern line  
of lot fifteen (15), N. 47-0 W., one hundred and ten (110) feet, to an iron pin,  
joint rear corner of lots fifteen (15) and sixteen (16); thence along the line  
of lot eighteen (18) N. 43-0 E., sixty (60) feet, to an iron pin, joint rear  
corner of lots sixteen (16) and seventeen (17); thence along the southern line  
of lot seventeen (17), S. 47-0 E., one hundred and ten (110) feet, to an iron  
pin, the beginning corner, said lot being known and designated as lot numbered  
sixteen (16) on Plat of said property recorded in the Office of the Register of  
Mesne Conveyance for Greenville County in Plat Book "R" at page 127, which Plat  
is hereby referred to and made a part hereof.

Said property is sold subject to the following restrictions, which con-  
stitute a part of the consideration therefor and shall be effective for a period  
of twenty-five (25) years from the date hereof:-

- (1) Said property shall be used for residential purposes only.
- (2) No residence shall be erected thereon at a cost of less than four  
thousand dollars (\$4,000.00.).
- (3) No house shall be erected thereon nearer the western edge of said  
sidewalk running along Darlington Avenue than twenty (20) feet.
