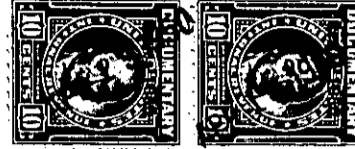

Lot No. 40: Beginning at an iron pin on the eastern side of Patton Road at the joint corner of Lots Nos. 40 and 41 and running thence along the line of Lot No. 41 N. 70-12 E. 165 feet to an iron pin; thence along an alley N. 19-58 W. 75 feet to an iron pin; thence along the line of Lot No. 39 S. 70-12 W. 165 feet to an iron pin; thence along the eastern side of Patton Road S. 19-58 E. 75 feet to an iron pin at the point of beginning.

Lot No. 41: Beginning at an iron pin on the northern side of Orders Drive at the joint front corner of Lots Nos. 41 and 42 and running thence along Orders Drive N. 82-04 W. 66.4 feet to an iron pin; thence along a curved line N. 53-51 W. 43.9 feet to an iron pin in Patton Road; thence along Patton Road N. 25-38 W. 79.6 feet to an iron pin; thence along the line of Lot No. 40 N. 70-12 E. 165 feet to an iron pin; thence along the western end of an alley S. 6-42 W. 20.1 feet to an iron pin; thence along the line of Lot 42 S. 6-42 W. 144.6 feet to an iron pin at the point of beginning.
