All that piece, parcel or lot of land, with the improvements thereon, situate, lying and being in or near the City of Greenville,
Greenville County, South Carolina, and being more particularly described as Lot 44, Section A, as shown on a plat entitled "A
Subdivision for Woodside Mills, Greenville, S. C.", made by Pickell & Pickell, Engineers, Greenville, S. C., January 14, 1950, and re-
corded in the R. M. C. Office for Greenville County in Plat Book W. at pages 111-117, inclusive. According to said plat the within
described lot is also known as No. 2 Vance Street (Avenue) and fonts thereon 51.2 feet.

The grantor and its predecessors in title have granted unto Parker Water & Sewer Sub-District Commission. Commissioners of Public Works of the City of Greenville, S. C., Greater Greenville Sewer District Commission, Greenville Traction Company, Duke Power Company and its predecessors Southern Power Company and Southern Public Utilities Company, Conestee Mills, Southern Bell Telephone and Telegraph Company, Southern Railway Company and its predecessor Greenville, Spartanburg and Anderson Railway Company, Southern Railway Company, and others all water and sewer pipe lines (other than house lines), electric light and power lines, including all pipe (other than house water and sever lines), valves, fire protection, electric light and power distribution, and sewerage systems of the community known as Woodside Mill Community in which the above described location, and operation (including meter reading) of the lines and systems aforesaid and of certain other railroad, water, sewer, electric, telephone, street trolley, and power lines constructed or to be constructed, and to relocate certain of such lines so as to run them in, along, above or near the streets and alleyway located in Woodside Mill Community and to operate and maintain the lines as so relocated, all as will more fully appear by reference to the records in the There is excepted and excluded from this conveyance so much of the personal property above mentioned as may be located upon the lot above described and excluded from this conveyance so much of the personal property above mentioned as may be located upon the lot above described and excluded from this conveyance so much of the personal property above mentioned as may be located upon the lot above described to the records in the contraction.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, and his (her or their) Heirs and Assigns forever.

And the said Woodside Mills does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his (her or their) heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
