We, Gaynelle M. Bates and Virginia B. Kentera, as Executrixes of the Estate of Robert D. Bates, deceased in the State aforesaid, in consideration of the sum of Eleven Hundred, Twenty-five and no/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Margaret W. Pruitt, her heirs and assigns forever

All that certain piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 51, Block D, according to plat of the property of Mrs. Corinne Bates made by Pickell & Pickell, Engineers, May, 1946, said plat being of record in the R. M. C. Office for Greenville County in Plat Book S, at page 57 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of the Old Spartanburg Road at the joint front corner of Lots Nos. 50 and 51 and running thence with line of Lot No. 50 in a northwesterly direction 200 feet to an iron pin at the rear corner of Lot No. 50; thence along the line of Lot No. 49 N. 56-12 E. 80 feet to an iron pin; thence N. 56-37 E. 20 feet to an iron pin, corner of Lot No. 52; thence along the line of Lot No. 52 in a southwesterly direction 200 feet to an iron pin on the north side of the Old Spartanburg Road; thence along the north side of the Old Spartanburg Road S. 56-37 W. 100 feet to an iron pin at the point of beginning, being one of the same lots of land conveyed to Robert D. Bates by Corinne Bates, individually and as trustee by deed dated May 7, 1948 and of record in the R. M. C. Office for Greenville County in Deed Book Volume 346, at page 105.

Grantee to pay all taxes for the Year 1950. The lot above described is conveyed subject to the following conditions and restrictions which shall inure to the benefit of the adjacent property owners: (1) Said premises shall be used exclusively for residential purposes and no residence other than outhouse shall be erected upon said lot at a cost of less than \$7,500.00 (2) Said lot shall not be resubdivided.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
