

W. H. Turner, Jr., and Maurice R. Turner, their heirs mand assigns All that certain tract of land in Cleveland Township, Greenville County, South Carolina, having the following metes and bounds:

BEGINMING at a poplar tree and running thence N. 89 W. 512.12 ft. to a stone; thenc southwardly 530 ft. more or less, to a pin in center of road; thence with the center of said road N. 80-15 E. 230 ft. to a pin corner of Tract No. 3 according to plat hereinafter mamed; thence continuing with center of said road S. 89 E. to plat hereinalter mamed; thence continuing with center of said road S. 69 E. 100 ft. and S. 71 E. 100 ft. to iron pin in center of said road corner of Tract 2; thence with line of Tract 2, N. 56 E. 200 ft. to a pin; thence N. 16 W. 235.6 ft. to a black gum tree; thence N. 40 W. 82.5 ft. to a pin; thence N. 30-45 W. 82.5 ft. to a pin; thence N. 32 W. 75.24 ft. to a poplar the beginning corner. This being all of tract 3 and approximately half of Tract 4, according to plat of lands of J. C. Ragsdale Estate made by G. A. Ellis, June 27, 1937.

ALSO all that tract adjoining and south of the said mentioned road having the following metes and bounds:

BEGINNING at a pin in the road corner of Tract 4; thence with said road S.80-15 W. 230 ft., N. 71 W. 100 ft., N. 67 W. 170 ft., N. 50-45 W. 60 ft. to pin in said road; thence S. 12 W. 60 ft. to an iron pin in creek; thence with the creek as a line S. 61 E. 191.4 ft. to pin, S. 31 E. 132 ft. to a double sycamore; thence N. 59 E. 385 ft. to the beginning corner.


