R. GRIFFIN, his heirs and assigns, all that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, lying and being situate on the Southern side of Potomac Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot # 242, Pleasant Valley, according to plat of said subdivision prepared by Dalton & Neves in April, 1946, including additions to said plat through May, 1948, as recorded in the R.M.C. Office, Greenville, South Carolina, in Plat Book "P", at Page 92; and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Potomac Avenue at joint front corner of Lots # 241 and # 242, said pin being 155 feet Southwest of iron pin in the Southwest corner of the intersection of Potomac Avenue and Long Hill Street; thence S. 0-08 E. 160 feet to an iron pin at joint rear corner of Lots # 241 and # 242; thence N. 89-52 E. 60 feet to an iron pin at joint rear corner of Lots # 242 and # 243; thence N. 0-08 W. 160 feet to an iron pin at joint front corner of Lots # 242 and # 243 on the Southern side of Potomac Avenue; thence along said Avenue, S. 89-52 W. 60 feet to an iron pin at joint front corner of Lots # 241 and # 242, the point of beginning.

The herein named grantee is to pay the 1950 taxes on the above-described property.
